Urgent Attention Candidates & State Counselling Authorities:

As per directions of Hon'ble Supreme Court of India in Contempt Petition No. 289 of 2022 in W.P No. 223 of 2022 Shubhankar Patnaik Vs.K.RameshReddy &Ors. the filtering out of joined All India Quota candidates is mandatory before stray vacancy round of state UG counselling.

In view of above, it is informed that the final result of Stray Vacancy Round of UG Counselling 2025 conducted by MCC has already been published and there is no provision of resignation in this round. Hence, all state counselling authorities are requested to weed out the allotted candidates of AIQ before seat processing of stray vacancy round of state counselling so that candidates holding a seat in AIQ are not allotted any seat through state counselling. State counselling authorities can download the list of joined candidates from the data sharing portal of MCC.
