## **PUBLIC NOTICE ROUND -5 (STRAY ROUND-2 BDS)**

It is for the information of all the eligible candidates desirous of seeking admission to BDS Course in Govt./ Private Dental Educational institutes in the State of Haryana, including those under Private University - SGT University, Budhera, Gurugram for Academic Session 2025-26, the tentative schedule **ROUND-5 (STRAY ROUND-2 BDS)** for counseling is as under:

### **Note:-**

1. The candidates, who have already registered themselves for the Round-1, Round-2 & Round-3 and Stray Round-1 and wish to participate in the Round-5 (Stray Round-2 BDS), shall not be required to register again.
2. **The candidates, who have been allotted seats to them in the Round-3 and Stray Round - I of State Counseling shall not be eligible to participate in the Round-5 (Stray Round-2 BDS)/ further round of counseling (if any).**
3. **The candidates who have already "joined" on any seat allotted to them upto Stray Round-1 through All India Counseling/Any State Counseling shall not be eligible to participate in the Round-5 (Stray Round-2 BDS)/further round of counseling even after resignation.**
4. All candidates (already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the **Round-5 (Stray Round-2 BDS)** of counseling and want to opt for State Quota Seats in only Government Dental Colleges shall be required to deposit online an amount of **Rs. 10,000/- (Rs. 5000/- for SC/SCD/BCA/BCB/EWS/PWBD of Haryana State)** and if the candidate wishes to also opt for **State Quota Seats/Management Quota Seats in Private Dental Colleges including Private Universities** the he/she shall have to deposit online an amount of **Rs. 1.00 Lakh**. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the **Round-5 (Stray Round-2 BDS)** of counseling.
5. In case of candidate join on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of UG Course.

6. **If the candidates are allotted any seat as per their preference in Round-5 (Stray Round-2 BDS), but they do not join on the allotted seat, the security amount shall be forfeited and these candidates will not be eligible to participate in the further round (if any).**
  7. The security amount of the candidates who are not allotted any seat during the Round 2/Round-3/Stray Round-1 shall be returned after the completion of the counseling process.
  8. The candidates, who had deposited security amount in Round-2/Round-3 / Stray Round-1 but not allotted any seat shall not deposit security amount for Round-5 (Stray Round-2 BDS).
  9. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.**
  10. **As per Govt. of Haryana notification dated 08.08.2025, Clause 9 XII (f), “after exhaustion of merit list of the candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted back to their original category(ies) of seats as per State Reservation Policy and filled up as per merit after conversion (For eg. BC-A seat to BC-B and finally to UR) and filled up in the 3rd round itself for both Government and Private Institutes. However, in case of any seat falling vacant after the 3rd round in any category, it shall first be offered to candidates belonging to original category of vacant seat of the previous round. In case, if the seat still remains vacant, the same shall be filled as per system in the 3rd round and so on”.**
  11. The choices filled by the candidates for the Round-1/ Round-2/Round-3/ Stray Round-1 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Stray Round-2 (BDS course).
  12. The above instructions should be read in accordance with NEET UG information bulletin 2025 and Govt. of Haryana notification dated 08.08.2025 and public notices issued time to time.
  13. Govt. of Haryana notification No. 40/13/2024-1SW dated 16.07.2024 is applicable for BC-A/BC-B category candidates.
