15. **The Candidates who have passed Class 12 from outside Haryana and want to avail benefit of resident of Haryana are required to submit an affidavit from their parent/guardian, duly attested by an Executive Magistrate, Oath Commissioner, or Notary Public, declaring that neither the deponent nor his/her child/ward has availed of the benefit of “Residence in any other State” as per Govt. of Haryana Notification dated 27.08.2026 Annexure IV (A).**
