All documents must be produced in original as per Govt. Notification along with two sets of self attested photocopies.

1. Matriculation/High School Certificate (10th).
2. 10+2/Intermediate/Senior Secondary School Examination Certificate & Detailed Marks Sheet.
3. Character Certificate issued by the school/institute last attended.
4. Resident Certificate issued by competent authority of the State Government (if applicable).
5. Caste Certificate issued by competent authority of the State Government (if applicable).
6. Certificate with respect to Benchmark Disabilities issued by the designated centers/PGIMS, Rohtak.
7. Certificate of Dependent of Freedom Fighters issued by competent authority of the State Government (if applicable).
8. Certificate of issued by Zila Sainik Board mentioning priority for ESM category candidates (if applicable).
9. Income Certificate (for BC Category students) issued by competent authority of the State Government (if applicable) as per Performa. BC category Candidates have to bring the income proof such as Form- 16/ITR/Salary statement of the last financial year (2019-20) as the case may be.
10. Income Certificate as per Annexure X for BC Category candidates issued by competent Revenue authority of the State Government.
11. Print out of Online Application form.
12. NEET Card, NEET Score Card & Provisional Allotment letter.
13. Proof of identification Aadhaar card / PAN Card / Driving license /Passport / Voter ID/Ration Card (any two).
14. Four passport size photographs against white background (preferably the same photograph used in NEET form).
15. Tuition fee in the shape of Demand Draft in favour of Counseling & Admission on A/c for Deptt. of Medical Education & Research (DMER) payable at Rohtak.
16. The Tuition fee can also be paid through NEFT/RTGS/Debit Card/Credit Card on the spot during MOP-UP Round.

In addition to above **NRI/OCI/PIO category candidates must bring the following documents at the time of document verification:-**

1. Passport.
2. Documentary evidence of NRI/OCI/PIO as per Govt. of India instructions issued from time to time.
3. Embassy Certificate (If applicable).
4. Sponsorship affidavit, stating that sponsorer is ready to bear the expenses for the whole duration of study (If applicable).
5. Relationship affidavit (Relation of candidate with sponsorer) if applicable.
6. Proof of NRE/NRI Bank Account detail.
7. NRI Category -V candidates must produce documentary evidence in support of their relationship with their sponsorer (as per Haryana Govt. notification No. 16/17/2019-6HB/IV dated 29.10.2020).
